## **Summary of Significant Career Events**

(1) Plowed Back to NATTC with seven other Naval Aviators. Formed a Mini-Squadron. Dead-sticked a T-33 from emergency low key with rough running engine when turbine blades cut loose and exited through the fuselage.

(2) Only Nugget to CARQUAL in the F-4 on a one day/ night CQ opportunity with a night pitching deck.

(3) TOPGUN graduate. Established Fighter Tactics Training Program within VF-14 as per TOPGUN guidelines and resources.

(4) Ordered to VF-43 to head the AIRLANT Adversary Program. Upgraded Fleet Fighter Air Combat Readiness Program. Provided ACM training for AIRLANT, Marine Corps, Reserve Air Wing TWENTY, and Air Force Squadrons.

(5) Developed extensive documentation for Chain-of-Command justification for additional aircraft assets for Adversary aircraft.

(6) COMFITWING ONE Fighter Pilot of the Year 1973.

(7) One of seven Navy Fighter Pilots selected as RED FORCE Adversary Pilots for JOINT TASK FORCE ACEVAL/AIMEVAL. XO of RED FORCE. Paid to win, not train.

(8) Multiple upgrades to F-14 Weapons Systems and AIM-9L leading to upgrades in AIM-9 series development as a result of ACEVAL/AIMVAL data.

(9) Designated COMFITWING ONE F-14 Performance Demonstration Pilot. Performed Multiple demonstrations for dignitaries touring USS *NIMITZ*.

(10) As CO of TOPGUN, provided training for the first F-18 crews to attend TOPGUN.

(11) AS CIC Officer directed the qualification of three ship SEA SPARROW mounts resulting in six BOOLA- BOOLAS.

(12) As CIC Officer and Operations Officer USS *JOHN F KENNEDY* clarified/marshalled COMCRUDESCRU TWO in Carrier/Air Wing operations.

(13) As CO USS *NIAGARA FALLS* during OPERATION DESERT STORM, serviced the Surface Combat Battle Group for duration of war. Danced around four Iraqi mines and destroyed all with EOD team embarked.

(14) As Assistant Director of Warfare Requirements for COMMANDER ATLANTIC FLEET, developed:
(a) LANTIRN proposal for F-14 Upgrade, (b) SH-60 Replacement of H-46 Logistics Delivery aircraft, and (c) AIRLANT/AIRPAC representative for initial warfare requirements for F-35.

(1) Employed by Raytheon and later General Dynamics providing guidance in operational capabilities desired by U.S. Navy for guided air-air and air-surface ordnance, Survival Radio requirements, and advanced tactical communications. (2) Pam and I retired to Spring Branch, Texas and experiment with ground launched sphere techniques and performance applications.
