Summary of Significant Career Events

- (1) While assigned as a nugget to VA-192, won the CVW-11 Bombing Derby (while deployed), made the Top Ten Hook for two-line periods, and as the Nuclear Safety Officer (NSO) successfully passed 3 NTPI inspections, including one surprise inspection.
- (2) At VX-5, flew weapon tests on A-7, A-4, A-6, and F-18 platforms including follow-on operational test & evaluation and at-sea preparations for the first F/A-18 deployment.
- (3) The tour with the Blue Angels included the transition from the A-4F to the F/A-18. Since I was the only demo pilot who had prior experience in the F/A-18, I was the transition officer for the team, modified flight controls, worked flight clearance issues, and wrote the initial Standard Operating Procedures so the team, which started winter training with an average of 10 hours in the aircraft, was ready to start the '87 season on time.
- (4) I was the 5th naval officer selected to the White House Fellowship Program and worked in the Office of Management & Budget at the end of the Reagan administration and beginning of the Bush term in office.
- (5) At the end of Operation DESERT STORM, and while still assigned to VFA-87, I participated in the debrief of combat performance (weapons).
- (6) I attended the Fletcher School of Law & Diplomacy due to the generous benefits of the Moreau scholarship, which allowed me to graduate with a Master of Arts in Law & Diplomacy and entered into the PhD program. I subsequently completed the dissertation and defended the work at Tufts University in 1999, returning to the ship in time for day/night CQ aboard CV-67 the following day.
- (7) I was in the Navy Annex, under the flight path of AA#77, heard the engines at full power, sensed the wing over our corner office window, when it hit the Pentagon on 9/11/01.
- (8) As Commander of US FIFTH Fleet, responsible for the evacuation of 15,000 US citizens from Lebanon, during the Israeli Hezbollah war in 2006. Once the Navy/Marine Corps team in place, there were life-threatening moments, international media coverage, and high drama getting everyone out of Lebanon safely. When we had all personnel embarked and underway in the eastern Mediterranean, under

clear skies...a fellow naval aviator in command of one of the amphibious ships broke the serious communications discipline over the net with one phrase, "sir, it looks like Woodstock at sea out here."

(9) As the US Pacific Fleet and JTF 519 Commander (JTF 519 is the only 4-star Standing Joint Task Force), we responded to the Great Eastern Japan Earthquake, tsunami, and radiation release on March 11, 2011 with Operation TOMODACHI (Friend), to the people of Japan. It was a 9.1 magnitude earthquake; Prime Minister Naoto Kan described the combined events inflicted the worst destruction in Japan since World War II.

Post Military Highlights

- (1) I am the oldest of 6 kids, my father worked at a Jesuit High School as a coach and administrator for approximately 50 years. I always wanted to return to my home-of-record, Dallas, TX, for life with family after a long career in the U.S. Navy.
- (2) In 2012, I joined Southern Methodist University (SMU) as a senior fellow. Additionally, I am the Chairman, Dallas Committee on Foreign Relations, Chairman, Board of Visitors, National Defense University. Formerly, I served two terms on the Board of Governors for the Center for Creative Leadership as well as a term as a board member for the East West Institute.
- (3) From 2012-2104, I was President of Strategic Programs, Academic Partnerships, LLC., where we helped public universities convert traditional degree programs to an online format to lower the barrier to admission in college programs and make degree programs more accessible.
- (4) In 2014 I received an offer to join a cyber threat intelligence group called iSIGHT Partners as a Senior Vice President. After acquisition by FireEye (NASDAQ: FEYE) in 2016, we developed an Enterprise Readiness framework, borrowing from many lessons in naval aviation, TOPGUN, and naval strike warfare to deliver actionable intelligence and operational readiness to network teams in the private sector.
- (5) In 2018, I was recruited by The Boeing Company, as Vice President for their Navy Marine Corps global services business, responsible for the full \$1.3B portfolio and associated training programs. This required a restructured business and a focused growth strategy to provide service solutions to the Navy Marine Corps aviation team and resulted in measurable improvements in fleet readiness.
- (6) I have recently retired from The Boeing Company, and joined Oliver Wyman, Inc., as a Senior Consultant with experience in the public, private, and non-profit sectors of the economy.

Personal:

By far, my proudest achievement – September 5, 1986 - during the introduction of the Blue Angels to the Atlanta community at the Dobbins AFB officer's club, I spied this beautiful woman surrounded by a bunch of guys (at least a dozen) all in their corporate suits. Realizing both the benefit of 20:20 vision and a very narrow window of opportunity, I leaned into the microphone and asked the master of ceremonies if we could have a picture with 'that girl' in the back of the room. Married to the former Andy Kaye Cooke on November 26, 1988, we are living the dream with 2 kids (Jennifer – a nurse in Boston, Matthew – a junior at Loyola Marymount University).
